- 5) The Brand Name Owner agrees that it will not sell, label or represent the product(s) listed herein as being certified by OC unless they have been manufactured/grown by the Certified Manufacturer/Grower pursuant to this agreement or by a new manufacturer/grower that has either a) Become certified organic by OC or b) Put in place a new agreement for the Brand Name Owner product(s).
- 6) Products not declared and covered by a private label agreement are prohibited from using any OC logo or any related statement or reference to OC.
- 7) The products covered under this agreement should be clearly identified to OC and the list maintained and up to date. The Certified Manufacturer/Grower agrees to maintain the comprehensive list of products covered under this agreement in one of the following ways:
